**What data do we process?**

We currently collect and process the following information: Basic personal data such as your name, address and contact details as well as information on how you qualify for the scheme.

**How do we receive your data?**

We normally receive your data directly from you either through a phone call, email or a reply slip (letter in the post). We may also receive your data from our Council partner (Greater Lincolnshire Council) if they have identified that you need support from us.

**Why do we process your data?**

The personal information we process is provided to us directly by you to enable us to install energy-efficient measures to your property utilising the Energy Company Obligation (ECO) funding stream.

**Who do we share your data with?**

- West Yorkshire Gas Solutions Limited (Our sub-contractor)
- Ofgem (Government regulator for electricity and gas markets)
- Greater Lincolnshire County Council (Our project partner)
- Utility Companies (i.e. British Gas or EON) (Funding Provider)

**Lawful Basis**

Under the UK General Data Protection Regulation (UK GDPR), the lawful basis we rely on for processing this information is Contractual Obligation, Consent & Legitimate Interest.

### **How we store your personal information**

Your information is securely stored.

We keep your name, address, contact details and qualification eligibility evidence for **10 years**. We will then dispose your information by removing it from our database.

### **Your data protection rights**

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

**Your right to restriction of processing** - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
