What data do we process?

We currently collect and process the following information: Basic personal data such as your name, address and contact details as well as information on how you qualify for the scheme.

How do we receive your data?

We receive your data directly from our Council partner (Derby City Council) when they have identified that you need support from us.

Why do we process your data?

The personal information we process enables us to install an energy efficiency measure in your property utilising the Home Upgrade Grant (HUG) government grant-funded scheme.

Who do we share your data with?

We may need to share your information with:

- Derby City Council (project partner)
- Renderclad (subcontractor)
- West Yorkshire Gas Solutions (subcontractor)
- Department for Business, Energy & Industrial Strategy (BEIS) (Governing body)
- Energy Saving Trust (EST) (Benefit eligibility confirmation)

- Elmhurst (EPC Accreditation body)
- ECMK (Retrofit Assessment Accreditation Body)
- Core Logic (Retrofit Assessment Software Provider)
- Trustmark (Government Endorsed Quality Scheme)
- CMS Surveyors (Technical Monitoring)

Lawful Basis

Under the UK General Data Protection Regulation (UK GDPR), the lawful basis we rely on for processing this information are Contractual Obligation.

How we store your personal information

Your information is securely stored.

We keep your name, address, contact details, qualification eligibility evidence and call recordings. All of our calls are recorded, when we require explicit consent we retain the call recording as proof of consent. After 6 years we will dispose of your information by removing it from our database.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

How to complain
