What data do we process?

We currently collect and process the following information: Basic personal data such as name, address, date of birth and contact details. Special category data including information about your health. Eligibility evidence which will include evidence of benefits and income where needed.

How do we receive your data?

We receive your data from our partner (High Aims Ltd) if they have identified that your property requires an Energy Performance Certificate (EPC) and/or a Retrofit Assessment as well as ECO paperwork administration as part of Platform Housing's programme of work.

Why do we process your data?

The personal information we process is provided to us so that we can carry out a Retrofit Assessment and an EPC which will highlight the energy efficient measures that are required in your property. The data will also enable us to claim ECO funding which goes towards the cost of your installation.

Your data protection rights

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
