What data do we process?

We currently collect and process the following information: Basic personal data such as your name, address and contact details. We may also collect details about your finances and information about your health (Special Category Data).

How do we receive your data?

We receive your data from our project partner Scottish and Southern Electricity Networks (SSEN) when they have identified that you could benefit from our support. SSEN will inform you that they are passing your data onto YES Energy Solutions.

Why do we process your data?

The personal information we process is provided to us directly by you to enable us to offer you advice on topics including but not limited to: your household energy bills, installing a smart meter and the benefits, energy saving advice that may help to reduce your energy usage.

Who do we share your data with?

We may need to share your information with:

- Scottish and Southern Electricity Networks (SSEN)
- Explain Market Research Ltd (Customer Satisfaction Surveys)

Lawful Basis

Under the UK General Data Protection Regulation (UK GDPR), the lawful basis we rely on for processing this information are: **Contractual Obligation.**

How we store your personal information

Your information is securely stored.

We keep your name, address, contact details, qualification eligibility evidence and call recordings. All of our calls are recorded, when we require explicit consent we retain the call recording as proof of consent. After **10 years** we will dispose of your information by removing it from our database.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

Your right to withdraw consent - In circumstances where consent has been used to process data, you have the right to withdraw your consent at any time. If you wish to withdraw your consent, please email us, or send a letter on our details below.

How to complain
