What data do we process?

We currently collect and process the following information: To enable referrals to be made, the processing of personal data relating to residential householders is required. Within the scope of this Agreement, the Partner Organisations agree that Personal Data will only be processed/or shared for the Specified Purposes listed below:

- a) To send and receive customer information to enable air permeability surveys to be coordinated.
- b) To report on the outcomes of each survey

How do we receive your data?

We receive your data directly from York Conservation via Electronic password protected file, secure, encrypted or otherwise secure file sharing, password protects or encrypted email, telephone.

Why do we process your data?

To ensure efficient contract delivery and customer engagement.

Who do we share your data with?

We may need to share your information with:

- York Conservation
- Internal YES departments

Lawful Basis

Under the UK General Data Protection Regulation (UK GDPR), the lawful basis we rely on for processing this information are: **Legitimate Interest.**

How we store your personal information

Your information is securely stored.

We keep your name, address, contact details and qualification eligibility until the end of the contract. We will then dispose of your information by removing it from our database.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

How to complain
